The third line is the internal lot coding system at Sconza Candy Company, says Lot and consists of a five digit number that begins with the last 2 digits of the current year and a 3 digit Julian day code. LOT23001 = 1/1/2023.

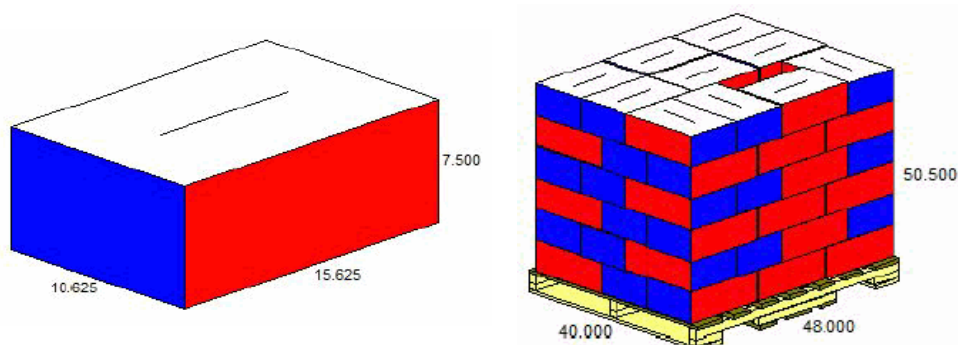
