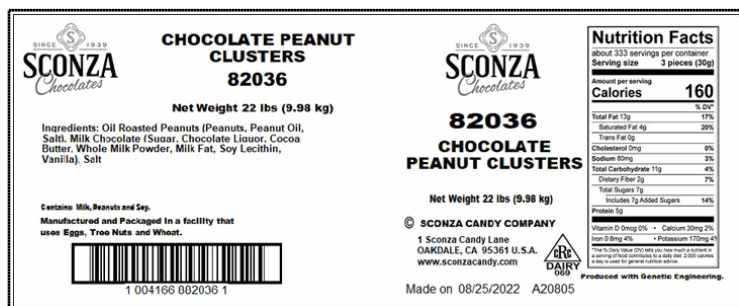

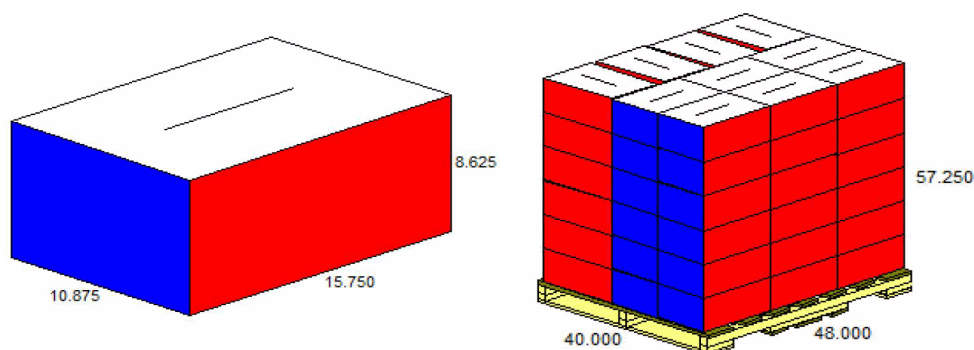
**Packaging and Weight:** 22 lbs in a bulk case with a clear liner and 1 outer case label (4x10).

**Pallet Pattern:** Code P22: 10 cases per layer X 6 layers per pallet = 60 cases.



**Metal Detection:** Packaged products are run through metal detectors as part of packaging process. Challenge sizes are 2.0mm ferrous, 2.5mm non-ferrous, 3.5mm 316 Stainless steel. Some packing lines use x-ray for metal detection with a limit of 1.5mm 316 stainless steel.

**Shelf Life:** Typically 6 months when stored between 60°F - 70°F and at a relative humidity of 50% or less.

**Food Guarantee:** All ingredients are food grade and production is compliant with the Federal Food, Drug and Cosmetic Act of 1938, Section 404 or 405 of the Act and all subsequent amendments and regulations.
